

# Ticketing Terms & Conditions of Entry

## **betr Darwin Triple Crown – AANT Club 2025**

*Updated 28 January 2025*

The Automobile Association of Northern Territory (**AANT**) stands as the largest membership-based association in the Northern Territory (**NT**), dedicated to serving the needs of Territorians for over six decades.

The ownership of the betr Darwin Triple Crown 2024 (**Event**) belongs to the Northern Territory Major Event Company (NTMEC).

AANT offers tickets for the Event (**the Offer**).

1. AANT will exclusively offer discounted hospitality packages to its Premium Member during a pre-sale period from 30 January 2025 until 28 February 2025 (or until sold out) at the following rates:
  - a) Single Day Pass (Saturday OR Sunday): \$475 (discounted)
  - b) Weekend Pass (Saturday AND Sunday): \$850 (discounted)
2. Any unsold tickets will be made available via the Supercars website ([darwinsupercars.com.au](http://darwinsupercars.com.au)) from 1 March 2025 until sold out at the following rates:
  - a) Single Day Pass (Saturday OR Sunday): \$520 (RRP)
  - b) Weekend Pass (Saturday AND Sunday): \$950 (RRP)
3. A limited number of tickets are available

These terms govern the AANT Club 2025 (**Venue**). By purchasing or possessing a ticket for the Event and Venue, you acknowledge and agree to adhere to these terms. Compliance with these terms is a prerequisite for ticket purchase and entry into the Venue.

1. The promoter is the Automobile Association of Northern Territory Inc ABN 13 431 478 529, located at 2/14 Knuckey Street, Darwin NT 0800, reachable via telephone at 08 8925 5901.
2. Eligible Premium Members and Eligible Customers are entitled to purchase tickets to the AANT Club 2025.
3. Tickets grant access the AANT Club hospitality area on the purchased days either; Saturday, June 21, and/or Sunday, June 22, 2025. When a weekend pass is purchased ticket holder will also gain General Admission at Hidden Valley on Friday, June 20, 2025. Access to restricted areas such as backstage, competition and performance zones, dressing rooms, VIP sections, and other hospitality zones (excluding the AANT Club) or any non-public areas of the Venue is strictly prohibited.
4. The Promotion Period commences at 9 am (ACST) on January 30, 2025, and concludes at 5 pm (ACST) on June 14, 2024, or upon the sale of 160 tickets, whichever occurs first.

5. In this Promotion, an Eligible Premium Member refers to an AANT Member with a valid Premium Roadside Assistance Membership. Expired Roadside Assistance Memberships are not considered Eligible Memberships. An Eligible Customer refers to an 18-year-old individual.
6. To qualify for the Offer, you must:
  - a. during the Promotion Period:
    - i. be an AANT member with an active Premium Roadside Assistance membership to access the discounted rate;
    - ii. be 18 years of age or older to access the full rate;
    - iii. provide AANT with a current email address and any other requested information related to the Promotion;

  - b. not terminate your AANT Premium Roadside Assistance Membership before Sunday, June 22, 2025.

8. Children aged 4 and above require a full-priced ticket.
9. Persons under 18 years of age must be accompanied by a ticket-holding parent or legal guardian.
10. If you do not meet the Eligibility Criteria but wish to avail the discounted rate Offer, you may become an AANT member by purchasing a Premium Roadside Assistance membership.
11. Tickets can be purchased online, over the phone (08 8925 5901) or in person at the AANT office (2/14 Knuckey Street, Darwin NT 0800).
12. Tickets will be delivered via email, but accreditations must be collected in person at the event.
13. Tickets and accreditations are non-transferable, non-exchangeable, and non-redeemable for cash. They must be used as specified, and no compensation will be provided if they cannot be utilised.
14. AANT bears no responsibility for any loss, cost, expense, damage, or liability incurred by you in connection with this Promotion, the Offer, or the Event, including any related to its officers, employees, contractors, or agents.
