Darwin Supercars 2024: Win AANT Club Hospitality Tickets! Competition Terms and Conditions

- 1. The promoter is the Automobile Association of Northern Territory Inc ABN 13 431 478 529 of 2/14 Knuckey Street, Darwin NT 0800, Australia (the Promoter, AANT).
- 2. Information on how to enter and eligibility to be entered into the draw and prize details form part of these terms and conditions. Participation is deemed acceptance of these terms and conditions.
- 3. Eligibility for inclusion in the prize draw for this competition is open to all persons who hold a valid, unexpired AANT Premium Membership with no payment in arrears as at 11.59pm the night before the respective draw, subject to clause 4.
- 4. This competition is restricted to AANT Premium members residing in the Northern Territory of Australia. All employees of the Promoter and those companies in which it has an equity interest, and the immediate families of such employees are ineligible to enter.
- 5. Competition opens at 09:00am on 11 June 2024 and closes on 14 June 2024 at 1:00pm (Competition Period).
- 6. - 14.
