- 1. The promoter is the Automobile Association of Northern Territory Inc ABN 13 431 478 529 of 2/14 Knuckey Street, Darwin NT 0800, Australia (the Promoter, AANT).
- 2. Information on how to enter and eligibility to be entered into the draw and prize details form part of these terms and conditions. Participation is deemed acceptance of these terms and conditions.
- 3. To qualify for the Competition you must:
 - i. Be an AANT Member with an active membership at the time of the promotion.
 - ii. Be 18 years or older.
 - iii. Be a resident of the Northern Territory
